1 **SB-09F-2369 : Student Physical Therapy Association Travel Request**

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The students of the Student Physical Therapy Association are Activity and Service fee
12 paying students looking to enhance the cultural and social interests of the students of the
13 University of North Florida, and;

14 Whereas: Student Physical Therapy Association, in order to further enhance the cultural and social
15 interests of the students of the University of North Florida, are seeking funding for travel to
16 the American Physical Therapy Association: Annual Combined Sections Meeting in San
17 Diego, California from February 17th, 2010 – February 20th, 2010.

18 Whereas: The Student Physical Therapy Association is requesting funding for the below items:

19	Registration:	9 Students	X	\$120.00 each	= \$1,080.00
20	Transportation:	3 Taxi's	X	\$17.30 / taxi	= \$51.90
21	Meals:	9 Students (4 days)	X	\$19.00 / Dinner	= \$684.00
