SB-09F-2371 : Catholic Ospreys Travel Request

14 Whereas: Catholic Ospreys, in order to further enhance the cultural and social interests of the students
15 of the University of North Florida, are seeking funding for travel to FOCUS National
16 Conference 2010 in Orlando, Florida from December 30th, 2009 – January 3rd, 2010.
