SB-10S-2379

1 **SB-10S-2379 : Exercise Science Student Association**

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The students of the Exercise Science Student Association are Activity and Service fee paying
12 students looking to enhance the cultural and social interests of the students of the University
of North Florida, and;

14 Whereas: Exercise Science Student Association, in order to further enhance the cultural and social
15 interests of the students of the University of North Florida, are seeking funding for travel to
16 the Southeast ACSM Annual Meeting in Greenville, South Carolina from February 10th,
17 2010 – February 13th, 2010.

18 Whereas: The Exercise Science Student Association is requesting funding for the below items:

19	Registration:	4 students	X	\$55.00 each	= \$220
20	Vehicle Rental:	1 car	X	\$163.11 each	= \$163.11
21	Fuel:	52.92 gallons	X	\$2.85 per gallon	= \$151
22	Meals:	4 students	X	\$127 per student	= \$508
