# SENATE LEGISLATION

## SB-10S-2382

### *SB-10S-2382 : Decentralize CSM Indexes*

2 Whereas: The Student Government of the University of North Florida was established to  
3 represent student concerns in all University wide matters; and

4 Whereas: The Student Senate is the legislative body of the University of North Florida's  
5 Student Government given the responsibility of carrying out such legislative acts that  
6 are necessary and proper for the Student Body of the University of North Florida;  
7 and

8 Whereas: Legislation pertaining to necessary and proper statutory recommendations shall be  
9 considered by Student Senate; and

10 Whereas: It has become evident that the Center for Student Media Indexes (Center for  
11 student media 402400, Spinnaker 402500, Osprey Television 402501, and Osprey  
12 Radio 402502) are able to operate independently as decentralized indexes;

13 Whereas: According to Title VIII 830.2 The SG Business Manager may recommend to the  
14 Student Senate to centralize or decentralize funded entities.

15 Whereas; The SG Business Manager has recommended that the Center for Student Media  
16 Indexes (Center for Student Media 402400, Spinnaker 402500, Osprey Television  
17 402501, and Osprey Radio 402502) be decentralized.

20 **Therefore: Let it be enacted, by the University of North Florida Student**  
21 **Government that the Center for Student Media indexes 402400, 402500, 402501 and**  
22 **402502 be decentralized effective immediately.**
