### *JR-10SB-2429 : University of North Florida Creed*

2 Whereas: The Student Government of the University of North Florida was established to create a representative  
3 government through which the individual student voice can be heard, and which students can actively  
4 participate in this University by promoting cooperation among the Student Body, Faculty, and Administration,  
5 and;

6 Whereas: This Government represents student concerns in all University-wide matters while developing and  
7 promoting programs and activities of practical value and interest to students, and;

8 Whereas: The student body of the University of North Florida is in need of more school spirit and "Osprey" Pride and;

9 Whereas: The University of North Florida does not have a creed in which to promote more school spirit and "Osprey"  
10 Pride, and;

11 Whereas: Other Universities across the country have a creeds that have successfully encouraged school spirit, community  
12 interest, and a more enjoyable experience at those universities, and;

13 Whereas: The student body at the University of North Florida would benefit from having a creed to embody its students;  
14 promote school spirit, pride, and a sense of unity among students, and;

15 Whereas: In representing student concerns, Student Government as a whole believes that this concern should be  
16 addressed;

17 Whereas: The Student Government of the University of North Florida believes that "The Osprey Creed" needs to be  
18 adopted and incorporated into every student related activity such as Sporting Events, Convocations, and  
19 Orientations;
