1	SB-16SB-3023: Osprey Voice Adjustments		
2 3	Whereas:	The Student Government of the University of North Florida was established to represent student concerns in all University wide matters, and;	
4 5 6	Whereas:	The Senate is the legislative body of the University of North Florida's Student Government given the responsibility of carrying out such legislative acts that are necessary and proper for the Student Body of the University of North Florida; and	
7 8	Whereas: Legislation dealing with necessary and proper statutory revisions to the System of Statutes shabe considered by the Senate; and		
9 10 11 12	Therefore:	The following revisions to Title XII Chapters 1204.3 and 1204.4 are being proposed in an effort to prevent any future scheduling conflicts with Osprey Voice and to remove the requirement that Senators must complete the Osprey Voice survey in order to be eligible to appeal their absentee point, respectively.	
13		TITLE XII: THE UNIVERSITY & STUDENT AFFAIRS COMMITTEE STATUTES	
14 15 16	Chapter 1204: Osprey Voice		
17 18 19		1204.1 The University & Student Affairs Committee is responsible for conducting Osprey Voice, a brief survey of the student body addressing issues of student interest.	
20 21 22 23		1204.2 Osprey Voice should be conducted at least once a month. At the first Senate meeting of each month, the University & Student Affairs Chair shall distribute a schedule of dates and a sign up form for Osprey Voice.	
24 25 26 27 28 29		1204.3 Every Senator must participate in at least one (1) Osprey Voice per month. If a Senator fails to attend an Osprey Voice, one (1) absentee point will be assessed. To be eligible to appeal these absentee points a Senator must turn in a completed Osprey Voice survey within three (3) business days after the most recent Osprey Voice.	
30 31 32 33 34		1204.4 The questions for Osprey Voice shall be drafted by the University & Student Affairs Chair and must be approved with majority vote by the University & Student Affairs Committee. Questions shall pertain to issues that could potentially affect the student body.
