2 Whereas: The Student Government of the University of North Florida was established to represent student  
3 concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission, which is to represent student concerns in all university wide matters while developing  
7 and promoting programs and activities of practical value and interest to students, and;

8 Whereas: RSOs and currently enrolled Activity and Service Fee-paying students may request funding for  
9 travel from the Student conference Travel Index according to chapter 841.1 of the Student  
10 Government Statutes and;

11 Whereas: According to chapter 841.2 of the same, Travel Requests fall under the jurisdiction of the Budget  
12 and Allocations Committee and are not subject to full Senate approval unless vetoed by the  
13 President or brought to the Senate floor as outline in Chapter 840.10 and according to 841.2, and;

14 Whereas: The request must receive a two-thirds (2/3) affirmative vote to pass, and;

15 Whereas: The purchase or activity reflects students' genuine interests and enhances the educational, social,  
16 cultural, and recreational services available to students at the University of North Florida, and;

17 Whereas: The person(s) listed below are Activity and Service Fee-paying students, who seek to manifest the  
18 above mentioned goals, and;

19 Whereas: Natalie Brown wishes to attend The 2017 Campus Moviefest Conference and Festival in Atlanta,  
20 Georgia from June 21, 2017 to June 26, 2017, and;

21 Whereas: Said individual is requesting funding for the below items:

22	Registration	= \$0
23	Lodging	= \$381.82
24	Transportation	= \$0
25	Total	= \$381.82

27 Therefore: Let it be enacted, by the University of North Florida Student Government, that \$381.82 be  
28 expended from the 2016-2017 FY Student Conference Travel Index 402028 to pay for the above  
29 referenced items.
