1 **SB-16F-3029: University Wide Committee Communication and Reporting**

2 Whereas: The Student Government of the University of North Florida was established to represent student  
3 concerns in all University wide matters, and;

4 Whereas: The Senate is the legislative body of the University of North Florida's Student Government given  
5 the responsibility of carrying out such legislative acts that are necessary and proper for the Student  
6 Body of the University of North Florida; and;

7 Whereas: The Student Body President is responsible for appointing and overseeing student government  
8 officials on University-wide committees;

9 Therefore: The following necessary and proper revisions to Title XII of the Student Government System of  
10 Statutes are being proposed in an effort to ensure future compliance with the law and the balance  
11 of our democratic system:

12 **Chapter 1203: USA Membership**

13 1203.1 All voting members of the committee will be elected or appointed Senators including the  
14 Vice Chair.

15 1203.2 Non-voting ex-officio members shall include all other presidentially-appointed members  
16 of the student body who are appointed to University-wide committees, the Student Advocate, and  
17 the SG Advisor.

18 1203.3 All members, voting and non-voting, who sit on University-wide committees shall be  
19 responsible for collecting agendas and minutes from their assigned University-wide committee  
20 meetings and turning them in to both the USA Chair and the Student Body President within two  
21 (2) business days of their regularly scheduled meeting time. Failure to do so shall result in  
22 consequences as outlined in Chapter 1208.

23 **Therefore: Let it be enacted that the following changes to Title XII be made effective immediately**  
24 **upon passage.**




