JR-18F-3309: Resolution on the Division of the Area Formerly Known as the Skate Park

- 2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;
- 4 Whereas: The Senate is the legislative body of the University of North Florida's Student Government
5 given the responsibility of carrying out such legislative acts that are necessary and proper for the
6 Student Body of the University of North Florida; and;
- 7 Whereas: The Student Government of the University of North Florida has the responsibility and
8 constitutional duty to advocate for matters pertaining to the student body; and;
- 9 Whereas: The Student Government of the University of North Florida is responsible for the allocation
10 of Activity and Service Fees and is also responsible for determining the use of items, programs,
11 or structures bought with said fees; and;
- 12 Whereas: It is important to provide clarification on how these resources should be used; and;
- 13 Whereas: The concrete slab area (which was the former "Skate Park") is currently being shared by the
14 Coastal Engineering and Ogier Gardens; and;
- 15 Whereas: The Student Body President would like support from Senate in issuing a formal opinion that
16 the concrete slab should officially be shared between both the Coastal Engineering Department
17 and the Ogier Gardens.
- 18 **Therefore: Let it be enacted that Student Government issue a formal opinion to address the division
19 of the concrete slab area, thus supporting the sharing of the property between the
20 Coastal Engineering Department and the Ogier Gardens. This resolution, upon
21 passage, shall be effective immediately.**
- 22 **Furthermore: Let this resolution be forwarded to the aforementioned Department of Coastal
23 Engineering, Ogier Gardens, Dr. Pamela Chally, Interim Provost and Vice President of
24 Academic Affairs, and the UNF Space Committee.**
