JR-18SA-3302: Resolution on the Coastal Biology Department's Presence on Old Skate Park Grounds

- 2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;
- 4 Whereas: The Senate is the legislative body of the University of North Florida's Student Government
5 given the responsibility of carrying out such legislative acts that are necessary and proper for the
6 Student Body of the University of North Florida; and;
- 7 Whereas: The Student Government of the University of North Florida has the responsibility and
8 constitutional duty to advocate for matters pertaining to the student body; and;
- 9 Whereas: The Student Government of the University of North Florida is responsible for the allocation
10 of Activity and Service Fees and is also responsible for determining the use of items, programs,
11 or structures bought with said fees; and;
- 12 Whereas: It is important to distinguish between ~~university and~~ student resources and other university
13 resources on matters pertaining to Activity and Service (A&S) Fees; and;
- 14 Whereas: The concrete slab area (which was the former "Skate Park") is currently being shared by an
15 Academic Department (Coastal ~~Biology~~ Engineering), which is a University Department, and
16 Ogier Gardens; and;
- 17 Whereas: This concrete area was funded by ~~students~~ Student Governmen using A&S Fees, which come
18 from the students; and;
- 19 Whereas: The Student Body President would like support from Senate in issuing a formal opinion of
20 Student Government on the matter of the Coastal Engineering ~~Biology~~ Department not
21 extending its presence at the area formally known as the "Skate Park" past the month of August,
22 2018.
- 23 **Therefore: Let it be enacted that Student Government issue a formal opinion to address the issue**
24 **of the Coastal ~~Biology~~ Engineering Department using the "Skate Park" area. This**
25 **resolution, upon passage, shall be effective immediately.**

26 **Furthermore: Let this resolution be forwarded to the aforementioned Department of Coastal ~~Biology~~**
27 **and Dr. Mauricio González (The Vice President of Student and International Affairs).**
