- 2 Whereas: The Student Government of the University of North Florida was established to represent student
3 concerns in all University wide matters, and;
- 4 Whereas: The Senate is the legislative body of the University of North Florida's Student Government given
5 the responsibility of carrying out such legislative acts that are necessary and proper for the Student
6 Body of the University of North Florida; and;
- 7 Whereas: The Student Government of the University of North Florida recognizes students who go above
8 and beyond to demonstrate excellence in their work; and;
- 9 Whereas: On April 30, 2019, Kyle DuBrava, working for the Student Union, acted professionally and with
10 leadership when he leaped into action upon discovering a University employee unresponsive in
11 the West Building.

13 workers calm in this situation of distress and allowed for minimal impact on SU operations while
14 emergency personnel responded.
