*SB-17S-3119: Correction to Title XI Overhaul*

- 1 Whereas: The Student Government of the University of North Florida was established to represent  
2 student concerns in all University wide matters, and;
- 3 Whereas: The Senate is the legislative body of the University of North Florida’s Student Government given  
4 the responsibility of carrying out such legislative acts that are necessary and proper for the  
5 Student Body of the University of North Florida;
- 6 Whereas: An Agency is an administrative division of the Executive Branch created to provide support,  
7 entertainment, and education for students of the University of North Florida;
- 8 Whereas: The following changes to Title XI were amended and approved by the Constitution and Statutes  
9 Committee on February 20<sup>th</sup>, 2017; however, these particular changes were not included in the  
10 legislation that was approved by the Senate on February 27<sup>th</sup>, 2017;
- 11 Therefore: The following necessary and proper revisions to the Student Government System of Statutes are  
12 being proposed:

**TITLE XI: THE EXECUTIVE AGENCY STATUTE**

14 Chapter 1103: Lend-A-Wing Pantry

16 1103.1 Director

18 A. Powers and Duties of the Director

- 20 1. The Director is a paid position that is responsible for maintaining the Lend-A-  
21 Wing Pantry and is tasked with ensuring there is a safe place for students in  
22 need.
- 24 2. The Director is responsible for all operations of the Agency, which may  
25 include, but are not limited to, maintaining the Agency website, conducting  
26 meetings when deemed appropriate, and keeping records of all financial  
27 transactions the Agency is responsible for.
- 29 ~~3. The Director must report all Foundation transactions to the SG Treasurer.~~

31 1103.4 Assistant Director

33 A. Powers and Duties of the Assistant Director

- 35 ~~4.3.~~ The Assistant Director is a paid position that assists the Director in his or her  
36 duties.

38 5.4. Additional duties may include aiding the Director with coordinating volunteers

43 B. The Lend-A-Wing Pantry shall have the right to establish standing committees as the  
44 leadership deems necessary.

46 1103.6 The Foundation Account

48 ~~A. The Foundation Account may only be used to purchase food or hygienic food, hygienic~~  
49 ~~items, or any other item with the exception of membership fees for wholesale/warehouse~~  
50 ~~establishments that supports the purpose of the Lend-a-Wing Pantry. The Foundation~~  
51 ~~Account may be used to purchase food, hygienic items, or any other item that supports~~  
52 ~~the purpose of the Lend-a-Wing Pantry.”~~

54 B.A. The Foundation account must maintain at least \$5,000 at all times.
