***SB-18F-3331: Validation of Acclamation of Fall 2018 Senatorial Candidates***

1 Whereas: The Student Government of the University of North Florida was established to represent  
2 student concerns in all University wide matters, and;

3 Whereas: The Senate is the Legislative Branch of the University of North Florida's Student Government  
4 charged with the responsibility of carrying out such legislative acts that are necessary and  
5 proper for the Student Body of the University of North Florida; and;

6 Whereas: Article V, Section 6 of the Student Government Constitution directs that in the absence of a  
7 legitimate challenge to the validity of a General Election the Student Senate shall vote to  
8 validate the election results, and;

9 Whereas: The Elections Commissioner has, in conjunction with the Attorney General and the  
10 Chief Justice, verified the accuracy of all Fall 2018 candidate's conduct and qualification  
11 to be acclaimed, in accordance with Title VI as well as all applicable Election Policies  
12 and Procedures, and;

13 Whereas: In accordance with Chapter 602.8 C.6 – "Unopposed candidates shall be declared the  
14 winner by acclamation and no election for the respective seat shall be held," and;

15 Whereas: This Senate Bill is being presented in compliance with Article V of the Constitution, as  
16 well as Title VI, Chapter 603.7 of the System of Statutes, and;

17 Therefore: The following Fall 2018 Acclamation of Senatorial Candidates results are being  
18 presented for Validation:
