SB-18S-3298: American Choral Directors Association

- 1 Whereas: The Student Government of the University of North Florida was established to represent
2 student concerns in all University wide matters, and;
- 3 Whereas: The Budget and Allocations Committee is a standing Committee of the Student Government
4 Senate responsible for funding only those entities that comply with the student Government
5 mission which is to represent the student concerns in all university wide matters while developing
6 and promoting programs and activities of practical value and interest to students, and;
- 7 Whereas: RSOs and currently enrolled Activity and Service Fee-paying students may request funding for
8 travel from the Student Travel Index according to chapter 841.1 of the Student Government
9 Statutes and;
- 10 Whereas: According to chapter 841.2 of the same, Travel Requests fall under the jurisdiction of the Budget
11 and Allocations Committee and are not subject to full Senate approval unless vetoed by the
12 President or brought to the Senate floor as outline in Chapter 840.10 and according to 841.2,
13 and;
- 14 Whereas: The request must receive a two-thirds (2/3) affirmative vote to pass, and;
- 15
- 16 Whereas: The purchase or activity reflects students' genuine interests and enhances the educational, social,
17 cultural, and recreational services available to students at the University of North Florida, and;
- 18 Whereas: The person(s) listed below are Activity and Service Fee-paying students, who seek to manifest
19 the above mentioned goals, and;
- 20 Whereas: Two students from the American Choral Directors Association wish to attend the Choral Music
21 Experience Institute from June 18, 2018 to June 23, 2018, and;
- 22 Whereas: American Choral Directors Association is requesting funding for the below items:
