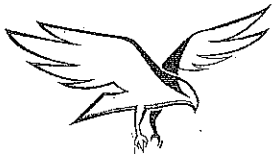

# SENATE LEGISLATION

## SB-19S-3380

1 *SB-19S-3380: Ultimate Frisbee Club*

2 Whereas: The Student Government of the University of North Florida was established to represent student  
3 concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission, which is to represent student concerns in all university wide matters while developing  
7 and promoting programs and activities of practical value and interest to students, and;

8 Whereas: RSOs and currently enrolled Activity and Service Fee-paying students may request funding for  
9 travel from the Student Travel Index according to chapter 842.1 of the Student Government  
10 Statutes and;

11 Whereas: According to chapter 842.2 of the same, Travel Requests fall under the jurisdiction of the Budget  
12 and Allocations Committee and are not subject to full Senate approval unless vetoed by the  
13 President or brought to the Senate floor as outlined in Chapter 840.9 and according to 842.2, and;

14 Whereas: The request must receive a two-thirds (2/3) affirmative vote to pass, and;

15 Whereas: The purchase or activity reflects students' genuine interests and enhances the educational, social,  
16 cultural, and recreational services available to students at the University of North Florida, and;

17 Whereas: The person(s) listed below are Activity and Service Fee-paying students, who seek to manifest the  
18 above mentioned goals, and;

19 Whereas: Twenty (20) students from the Ultimate Frisbee Club wish to attend Georgia Southern  
20 Tournament in Statesboro, GA from March 22<sup>nd</sup>, 2019 to March 24<sup>th</sup>, 2019, and;

21 Whereas: Said individual/RSO is requesting funding for the below items:

22	Registration	= \$350.00
23	Lodging	= \$750.00
24	Transportation	= \$330.00
25	Total	= \$1,430.00

27 **Therefore:** Let it be enacted, by the University of North Florida Student Government, that \$1,430.00  
28 be encumbered in the FY 2018-2019 Student Travel Index 402028 in order to pay for the  
29 above referenced items.
