SB-20S-3480: Title III Changes

- 1 Whereas: The Student Government of the University of North Florida was established to represent
2 student concerns in all University wide matters, and;
- 3 Whereas: The Constitution and Statutes Committee is a standing Committee of the Student
4 Government Senate responsible for approving and forwarding any changes to Student
5 Government Statutes to the Senate for approval, and;
- 6 Whereas: The Executive Agency Club Alliance has been renamed Student Involvement Center, and;
- 7 Whereas: The Chair of the Club Funding Board is no longer the Club Alliance Director, and;
- 8 Whereas: The Directors and Staff of Executive Agencies have traditionally served in their roles until the
9 end of the Spring semester, not the end of the president's term, and;
- 10 Therefore: The following necessary and proper revisions to the Student Government System of Statutes
11 are being proposed in an effort to ensure future compliance with the law and the balance of
12 our democratic system:

14 **TITLE III: THE EXECUTIVE BRANCH**

15 Chapter 304: Treasurer

17 304.1 The Treasurer shall:

- 18
19 A. Enforce all fiscal policies of Student Government as set forth in this title, in the provisionary
20 language of the current year's A&S Fee Budget, and in the Policies and Procedures established
21 and enacted by the Senate;
- 22
23 B. Periodically check the A&S Fee accounts to correlate with language and expenditures set by the
24 current year's budget;
- 25
26 C. Submit a proposed balanced A&S Fee Budget during the Annual Budget Process;
- 27
28 D. Serve as a fiscal advisor to the Senate and the Budget and Allocations (B&A) Committee;
- 29
30 E. Advise and aid RSOs on fiscal policies set by Student Government and meet bi-weekly with the
31 Chair of Club Funding Board ~~Club Alliance Director~~ to review all fiscal matters relating to RSOs;

33 Chapter 308: Presidential Appointment and Dismissal Powers

34 308.2 Appointment to Executive Branch Positions

- 36 A. The President shall appoint all non-elected members of the Executive Branch.
- 37
- 38 B. Any Individual appointed to an Executive Cabinet position shall require confirmation by a
- 39 majority vote of the Senate.
- 40
- 41 C. Any individual appointed to an Executive Cabinet position who has yet to have been
- 42 confirmed shall be referred to as an acting member of the executive branch and will receive
- 43 compensation until said individual can be forwarded to the Senate for confirmation. Acting
- 44 members of the Executive Branch shall come before Senate for confirmation at the next Senate
- 45 meeting following their appointment, unless an extraordinary circumstance prevents them
- 46 from doing so, and may not serve longer than thirty (30) days without confirmation. The
- 47 President must report any Acting Executive Branch member's first official day of work to the
- 48 Senate President.
- 49 D. The terms of all presidentially appointed positions will end with the term of the President,
- 50 with the exception of the Elections Commissioner and Associate Justices:
- 51 1. Elections Commissioner,
- 52 2. Associate Justices,
- 53 3. Agency Directors and their staff.
- 54 A. The Assistant Director for Involvement and the Involvement Coaches are
- 55 selected in the Fall Semester and their term will last for one (1) -year from the
- 56 hire datecalendar year.
- 57 B. All other Agency positions' term will end on the last day at the end of the Spring
- 58 Semester.
