***SB-20S-3494: Yoannis Hermida***

1 Whereas:  
2 The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas:  
5 The Budget and Allocations Committee is a standing Committee of the Student Government  
6 Senate responsible for funding only those entities that comply with the Student Government  
7 mission which is to represent the student concerns in all university wide matters while developing  
8 and promoting programs and activities of practical vale and interest to students, and;

9 Whereas:  
10 RSOs and currently enrolled Activity and Service Fee-paying students may request funding for  
11 travel from the Student Travel Index according to chapter 842 of the Student Government  
12 Statutes and;

13 Whereas:  
14 According to chapter 841.2 of the same, Travel Requests fall under the jurisdiction of the Budget  
15 and Allocations Committee and are not subject to full Senate approval unless vetoed by the  
16 President or brought to the Senate floor as outlined in Chapter 840.9 and according to 842.2,  
17 and;

18 Whereas:  
19 The request must receive a two-thirds (2/3) affirmative vote to pass, and;

20 Whereas:  
21 The purchase or activity reflects students' genuine interests and enhances the educational, social,  
22 cultural, and recreational services available to students at the University of North Florida, and;

23 Whereas:  
24 The person(s) listed below are Activity and Service Fee-paying students, who seek to manifest  
25 the above-mentioned goals, and;

26 Whereas:  
27 **Yoannis Hermida** who wish to attend **International Conference of Thinking in Paris,**  
28 **France from July 21, 2020 to July 25, 2020,** and;

29	Whereas:	Said individual(s) is(are) requesting funding for the below items:	
30		Registration	= \$407.54
31		Lodging	= \$92.46
