***SB-20S-3499: Validation of Acclamation of Spring 2020 General Elections***

1   Whereas:    The Student Government of the University of North Florida was established to represent  
2                    student concerns in all University wide matters, and;

3   Whereas:    The Senate is the Legislative Branch of the University of North Florida’s Student Government  
4                    charged with the responsibility of carrying out such legislative acts that are necessary and  
5                    proper for the Student Body of the University of North Florida; and;

6   Whereas:    Article V, Section 7 of the Student Government Constitution directs that in the absence of a  
7                    legitimate challenge to the validity of a General Election the Student Senate shall vote to  
8                    validate the election results, and;

9   Whereas:    The Elections Commissioner has, in conjunction with the Attorney General and the  
10                  Chief Justice, verified the accuracy of all Spring 2020 candidate’s conduct and  
11                  qualification to be acclaimed, in accordance with Title VI as well as all applicable  
12                  Election Policies and Procedures, and;

13   Whereas:    In accordance with Chapter 602.8 C.6 – “Unopposed candidates shall be declared the  
14                  winner by acclamation and no election for the respective seat shall be held,” and;

15   Whereas:    This Senate Bill is being presented in compliance with Article V of the Constitution, as  
16                  well as Title VI, Chapter 603.7 of the System of Statutes, and;

17   Therefore:   The following Spring 2020 Acclamation of Candidate results are being presented for  
18                  Validation:
