JR-20F-3511: Joint Resolution Recognizing Senator Ryan See

- 1 Whereas: The Student Government of the University of North Florida was established to represent
2 student concerns in all University wide matters, and;
- 3 Whereas: The Senate is the legislative body of the University of North Florida’s Student Government given
4 the responsibility of carrying out such legislative acts that are necessary and proper for the
5 Student Body of the University of North Florida, and;
- 6 Whereas: Senator Ryan See transferred to the University of North Florida in the Spring of 2019, the same
7 semester he was appointed as a member of the Senate;
- 8 Whereas: Senator See was passionate about public policy, majoring in Political Science and minoring in
9 Public Administration and Policy and taking graduate level courses as an undergraduate;
- 10 Whereas: Within his first semester, Senator See was responsible for requesting funds to purchase new
11 microwaves in the Student Government lounge, an initiative that directly serves students;
- 12 Whereas: Senator See was passionate about Student Government and volunteered at any opportunity, and
13 will be remembered as an informed and intellectual student servant;

15 and genuine happiness to every event he attended and every person he met;
- 16 Whereas: Senator See will be deeply missed in Student Government and in the University of North Florida
17 community;
- 18 Therefore: Let it be known that the Student Government at the University of North Florida recognizes
19 Senator Ryan See for his extraordinary service to Student Government and the student body;
- 20 Furthermore: Upon passage, let the Student Government of the University of North Florida establish the
21 “Ryan See Senator of the Year Award” to be granted to a senator each year who exemplifies
22 Senator See’s altruistic attitude and commitment to serving the student body.
