SB-20F-3529: Budget Component for Forming the SKYS Executive Agency

Whereas:

1 The Student Government of the University of North Florida was established to represent
2 student concerns in all University wide matters, and;

Whereas:

3 The Budget and Allocations Committee is a standing Committee of the Student Government
4 Senate responsible for funding only those entities that comply with the Student Government
5 mission which is to represent the student concerns in all university wide matters while developing
6 and promoting programs and activities of practical value and interest to students, and;

Whereas:

7 The Budget and Allocations Committee is responsible for approving the budget component of
8 forming a new Executive Agency; and;

Whereas:

9 The proposed budget will go towards forming an Agency that is designed to ensure a safe
10 community for all students on campus by providing an escort service for students to get to places
11 safely on the main campus of the University of North Florida, and;

Whereas:

12 The following is an estimated breakdown of one fiscal year of the budgetary component for the
13 SKYS (Students Keeping You Safe) Executive Agency:

OPS Wages:

16	SKYS Director:	(\$10 * 20 hrs * 35 weeks) + FICA = \$7,102
17	SKYS Assistant Director:	(\$10 * 15 hrs * 33 weeks) + FICA = \$5,022
18	SKYS Pilots:	(\$10 * 15 hrs * 32 weeks)(10) + FICA = \$48,696

Operating Expenditures:

20	Marketing and Promotion:	\$1,500
21	Apparel	\$650
22	Equipment (walky-talky, flashlights, etc)	\$200
23	Food	\$100
24	Other Materials and Supplies	\$100

26 Total expecting cost of a year: \$63,37069

Therefore:

29 Let it be enacted by the University of North Florida Student Government that the
30 estimated fiscal year budget be approved for the SKYS Program so that SKYS may be
31 established as an Executive Agency.
