SB-21S-3562: Validation of Spring 2021 General Elections

1 Whereas: The Student Government of the University of North Florida was established to represent
2 student concerns in all University wide matters, and;

3 Whereas: The Senate is the legislative body of the University of North Florida's Student Government
4 charged with the responsibility of carrying out such legislative acts that are necessary and
5 proper for the Student Body of the University of North Florida; and;

6 Whereas: Article V, Section 7 of the Student Government Constitution directs that in the absence of a
7 legitimate challenge to the validity of a General Election the Student Senate shall vote to
8 validate the election results, and;

9 Whereas: The Elections Commissioner has, in conjunction with the Attorney General and the
10 Chief Justice, independently verified the accuracy of all Spring 2021 election results, in
11 accordance with Title VI as well as all applicable Election Policies and Procedures, and;

12 Whereas: This Senate Bill is being presented in compliance with Article V of the Constitution, as
13 well as Title VI, Chapter 603.26 of the System of Statutes.

14 Therefore: The following Spring 2021 General election results are being presented for validation:
