10 social, cultural, and recreational interests of the University of North Florida students and;
- 11 Whereas: The student, Paige Skipper is an Activity and Service fee paying student looking to enhance
the cultural and social interests of the students of the University of North Florida, and;
- 13 Whereas: Paige Skipper, in order to further enhance the cultural and social interests of the students of
14 the University of North Florida, is seeking funding for travel to the Association of College
15 Educators- Deaf and Hard of Hearing in Ft. Worth, Texas from February 16th, 2011 to
16 February 20th, 2011;
