3 Whereas: The Student Government of the University of North Florida was established to represent student
4 concerns in all University wide matters, and;

5 Whereas: The Budget & Allocations Committee is a standing committee of the Student Government Senate,
6 responsible for funding only those entities that comply with the Student Government mission,
7 which is to represent student concerns in all university wide matters while developing and
8 promoting programs and activities of practical value and interest to students, and;

9 Whereas: This purchase reflects the genuine interests of the Student Body, and enhances the cultural,
10 societal, and recreational well-being of the students; and;

11 Whereas: Student Government's subsidization of printing helps students make direct use of their A&S
12 dollars; and;

13 Whereas: This expenditure promotes the students' ease of access to printing facilities and resources; and;

14 Whereas: This expenditure facilitates a more equitable educational experience by providing a minimum
15 number of prints to every student; and;

16 Whereas: The Student Government Executive Branch is requesting the following:

18 Printing Cost \$2.10 x 16,000 =\$33,600.00

21 Total: =\$33,600.00

23 **Therefore:** Let it be enacted, by the University of North Florida Student Government, that \$33,600.00
24 be transferred from the Fiscal Year 2016-2017 Special Request Index 402097 to the Fiscal
25 Year 2016-2017 Student Government Executive Index 402060 to be used to pay for the
26 above items.

27 **Furthermore:** Any remaining funds at the end of the Fall 2016 semester, or any funds that will be unused
28 due to a revision in student enrollment, shall be returned to the Special Request Index
29 402097.
